Dear Students

Your dedication during, what remains a difficult year, is truly appreciated as we adjust to the uncertainty brought about by COVID-19. As you are aware, we have entered lockdown level 3, which means that access to our resources and facilities is a bit easier and, as such, we need to amend our delivery model accordingly. Herewith information regarding teaching delivery after 13 August 2021.

Delivery

- We will continue with the Three Phase Model for most of our programmes.
- You will be returning to campus to physically engage in the sessions where your presence is required (e.g., P1 and P3 sessions).
- We will no longer offer the hybrid facilitation mode of delivery after 13 August.
- Recordings will therefore not be kept.
- Recordings that were made will need to be deleted after two weeks.

Timetable

- Your timetable will stay the same.
- You will be required to physically attend the sessions that require synchronous interaction (e.g., P1 and P3 sessions). For students in the Education Faculty, this means that the 80% attendance rule applies for Face-to-Face sessions.
- P2/online activities are unaffected. You can complete these activities wherever you have access to a device and data. You should be completing P2/online activities so that lecturers can check your progress.

There are good reasons for returning to a Face-to-Face mode of delivery, particularly if you are struggling with data and connectivity. The data solution we have provided will assist you in completing your online activities and assessments. Our campuses remain fully compliant in terms of COVID-19 protocols.

We wish you all the best as you continue your studies in these challenging times.
